Proponents are requested to submit bids for various types of scrap metal available from the Essex-Windsor Solid Waste Authority. You may choose to submit bids on one or more types of metal. The following describes various scrap metals that are received at the following locations: Public Drop Off facility located at 3560 North Service Road, Windsor, the Kingsville Transfer Station located at 2021 County Rd. 31, Kingsville and the Regional Landfill located at 7700 County Road 18, Essex.

These metals will be segregated (by others) in the categories described below and when containers (40 cu. yd. - supplied by others) are full, they will be delivered to the facility of the successful bidder for **each** metal type.

Residue may be returned to the Authority at no cost; however, the Authority will not pay for the shipping costs of returning residue to the Public Drop Off Depot.

Tonnage estimates for each type are for a six-month period and are estimated and provided for information only. Quantities are not guaranteed.

Contractor’s metal drop-off location may affect final award for this sale of scrap metal contract.
