



2023 Regional Landfill Tipping Fee Schedule

The table below outline the **tipping fees** for various materials and waste types at the Regional Landfill in Essex. Only vehicles with a gross weight of 3 tonnes or more can bring in waste for disposal at this location.

Table One: Industrial/Commercial/Institutional Tipping Fee Schedule for 2023

<p>Refuse/Garbage Includes dirt and stumps (stumps over 36 inches in diameter, longer than 48 inches)</p>	<p>Charge Account Customers: \$64.00/tonne Cash Customers: \$6.40/100 kg (\$6.40 minimum charge applies)</p>
<p>Tree Trimmings/Brush Grass and Leaves</p>	<p>Charge Account Customers: \$51.00/tonne Cash Customers: \$5.10/100kg (\$5.10 minimum fee applies)</p>
<p>Asbestos</p>	<p>\$150.00 per tonne, plus a flat fee of \$150.00 per load. Disposal of asbestos is by appointment only and must be brought to the Landfill by a licensed M.O.E. Hauler. Please call 519-776-7941 for more information.</p>
<p>Contaminated Soil</p>	<p>\$38.00 per tonne. Accepted by approval only. Please call 519-776-7941.</p>
<p>Vines/Rockwool/Coco</p>	<p>\$45.00 per tonne</p> <ul style="list-style-type: none"> • Vine loads with 20% or more contamination will be invoiced at the Industrial/Commercial/Institutional (I/C/I) disposal rate. • All trucks must be equipped with front and rear tow hooks. • Containers/trucks must be leak proof to avoid spills. • Haulers must be Ministry of the Environment approved or have a Waste Management Systems Certificate. • Trucks must follow the designated haul route to and from the Regional Landfill. The designated haul route is Arner Town Line to County Road 18 then west to the landfill. • Vines shall be ground. • Odiferous vine loads will not be accepted. • All waste loads are subject to daily inspections. • The EWSWA reserves the right to discontinue accepting vine loads due to operational concerns or limitations.

Examples of other greenhouse waste includes, but is not limited to; plastic, drip tape, fruits, vegetables, and any other waste material that is not a vine or growing medium. |
